Agreement Terms:

Health and Genetic Testing:

- The breeder guarantees that the puppy has undergone comprehensive genetic testing to screen for common health conditions associated with the breed.
- The puppy is guaranteed to be in good health at the time of sale.
- In the event a genetic issue arises that contradicts the genetic report, the breeder will offer a partial refund of half of the purchase price if reported within two years from the date of sale.

Out of State Buyers

• If the puppy is to be transported out of state, the buyer is responsible for those costs in addition to the purchase price.

Veterinary Care:

The puppy has received its initial vaccines and deworming.

• The buyer agrees to continue regular veterinary care and maintain up-to-date vaccinations as recommended by a licensed veterinarian.

Return Policy:

- If the buyer is unable to keep the puppy for any reason, the breeder requests to be notified and given the first option to take the puppy back.
- The breeder does not offer refunds, but will offer a replacement within a month for another puppy from the same litter if any are still available and not reserved.
- In the event of a return, the buyer is responsible for any associated costs, including transportation.

Care and Maintenance:

- The buyer agrees to provide proper care in terms of diet, exercise, and living conditions.
- The buyer agrees to never leave the puppy in conditions where its welfare might be jeopardized (e.g., in extreme weather conditions, in a car, or without proper food and water).

Legal Clauses:

- Limitation of Liability: The breeder is not responsible for any accidents or injuries caused by the puppy after it leaves the breeder's premises and is only limited to the purchase price of the puppy.
- The breeder is not responsible for any health conditions not mentioned in the genetic report.
