Agreement Terms:

1. Ownership:

- The dog will reside with the guardian, but the breeder retains full ownership and breeding rights until the end of the dog's breeding career, at which point ownership will be officially transferred to the guardian via a mutually agreed-upon Ownership Transfer Document.

2. Breeding Rights and Responsibilities:

- The breeder has the right to breed the dog up to a maximum of 5 litters, or until the dog reaches the age of 7, or until a veterinarian advises against further breeding.
- The guardian will receive 15% of the profit from each litter as compensation.

- The guardian agrees to make the dog available for breeding purposes as required by the breeder.

3. Veterinary Care and Health Testing:

- The breeder will cover all costs associated with breeding and health testing, including any complications related to breeding.
- The guardian is responsible for routine veterinary care and any non-breeding-related medical expenses.

4. Care and Maintenance:

- The guardian agrees to provide proper care, including quality food, exercise, and a safe living environment.
- The dog must be kept well-groomed and in good physical condition.

5. Breeding Process:

- The guardian agrees to notify the breeder within 24 hours when the female dog goes into heat.
- Failure to notify in time resulting in a missed breeding opportunity will result in a \$500 fine or the return of the dog to the breeder. Only one missed heat notification due to extenuating circumstances is allowed. If there are 3 missed heat notifications, the dog must be returned immediately to Oodles of Bernedoodles.

6. End of Breeding Career:

- Upon completion of the dog's breeding career, ownership will be officially transferred to the guardian via the mutually agreed-upon Ownership Transfer Document.
- The breeder agrees to spay/neuter the dog at their expense before transferring ownership.

7. Legal Clauses:

- Indemnification Clause: The breeder is indemnified against any complications not related to breeding.
- Limitation of Liability: The breeder's liability is limited to complications related to breeding.

- Dispute Resolution: Disputes will be resolved through mediation.
- Force Majeure: Neither party is liable for failure to perform obligations due to events beyond reasonable control.
- Termination Clause: Either party may terminate this agreement under mutually agreed-upon conditions, with consequences outlined in the agreement.

8. Return Clause:

- If the guardian can no longer care for the dog, the dog must be returned to the breeder.

9. Agreement to Terms:

- Both parties agree to abide by the terms of this agreement and acknowledge that failure to do so may result in the return of the dog to the breeder.
